The purpose of this meeting was to review the work completed by the 2015 Standards Working Groups and to provide leadership training for the members.

A quorum was present (attendance sheet attached).

The meeting began on January 27, 2015, at 1:30 p.m. with the monthly webinar hosted by the Office of Accreditation. The topic was Corrective Action Plans (CAPs) led by Program Manager Christiana Halsey. In addition to the Board members present, more than 20 members of the accreditation community were online.

The Board reviewed the process and policy section of the FLETA Standard and Procedures Manual and made recommendations for updates and changes.

On January 28, 2015, Dr. Jack Enter presented a discussion on the Narrow Pathway of Leadership during the morning. During the afternoon Frank Sopper, of OpenBook, presented information on cognitive preferences via a webinar. He was unable to attend in person due to a winter storm in the northeast.


