Mr. Mitchell thanked the Office of Accreditation staff for all the hard work they completed to put this meeting together and for the work they complete on a daily basis.

CDR Wilbert announced the Board Review Committee (BRC) met on Wednesday, July 15, 2009, and conducted a review of the following agencies:

V. Accreditation Awards

<u>USCG – Basic Boarding Officer Course (BBOC)</u> – First Vice Chairman Don Webb called upon Board Member Nancy Stout, to report the results of the Board review of the BBOC. Ms. Stout reported the Board unanimously granted accreditation to this course. Representatives from the U.S. Coast Guard accepted the award of accreditation.

<u>FAMS – Federal Air Marshal Training Program 1 (FAMTP 1)</u> – CDR Wilbert called upon Board Member A.T. Smith to report the results of the Board review of the FAMTP 1. Mr. Smith reported the Board unanimously granted accreditation to this course. Representatives from the Federal Air Marshal Service accepted the award of accreditation.

<u>FLETC – Law Enforcement Instructor Training Program (LEITP)</u> – CDR Wilbert called on Board Member Edmond Winslow to report the results of the board review of the LEITP. Mr. Winslow reported the Board unanimously granted reaccreditation to this course. Representatives of the Federal Law Enforcement Training Center accepted the award of reaccreditation.

<u>USPIS – Postal Police Officer Basic Training (PPOBT)</u> – CDR Wilbert reported the results of the Board review of the provisional status of the accreditation of the PPOBT. CDR Wilbert reported the Board unanimously voted to change the provisional status of the PPOBT to full accreditation. Representatives of the U.S. Postal Inspection Service accepted the award of full accreditation.
